SCOTUS SAYETH ...

- **KSR Int'l v. Teleflex** (April 30, 2007): Rigid application of the Federal Circuit's TSM test is not proper analysis under § 103(a).
- **Microsoft Corp. v. AT&T** (April 30, 2007): Tangible copy of software can be "component" of a patented invention under § 271(f), but replication overseas not subsumed into act of supply.
